Legislative Report

The Washington State legislature is not in session now so this is a good opportunity to advocate for a permanent COLA for Plan 1 members. The annual recommendation

from the State Select Committee on Pension Policy (SCPP) carries tremendous weight. The legislators that we have talked to all said that they voted for that recommendation every year. The SCPP will be meeting next on September 19. We recently learned that House Majority Leader Joe Fitzgibbon has been elected SCPP Chair for the remainder of the year. Senator Drew MacEwan has been elected Vice Chair. Both legislators have a history of vocally supporting WSSRA and the Plan 1 COLA. WSSRA views this as a happy development.


